Again, is the time of the year to renew your credentials for the year 2024 with the Southern Pacific District.

Each year, the Secretary's office prepares to begin the process of credential renewal by sending the package ahead of time.

Please, we ask for you to take into account the following information. The renewal package will be available on our web site at www.spdag.org as of next week.

Remember, there are two renewals that must be done:

- 1. The Southern Pacific District Renewal to be completed by October 31, 2023
- 2. The General Council Renewal to be completed by December 31, 2023.

In our last General Presbytery in August 2023 a resolution passed, where since 2025 the Credential Renewal process with General Council will be done only online. For this reason, we recommend, if you are not renewing your credentials online, please to create an account at https://agpassport.ag.org/ and try to do it online this year. If you need further assistant with this matter, please do not hesitate to contact our office, we will be happy to assist you in the process.

CREDENTIAL RENEWAL PROCESS WITH SOUTHERN PACIFIC DISTRICT 2024

DEADLINE FOR SPD CREDENTIAL RENEWALS

- The renewal form must be in the district office with the mailing date postmarked no later than October 31, 2023 to be considered on time.
- ❖ LATE RENEWAL WITH SPD there is a fee for renewing late, please make checks payable to Southern Pacific District
 - o \$50.00 From November 1 to December 31, 2023
 - o \$75.00 From January 1 to January 15, 2024

HOUSING ALLOWANCE FORM

- Attached you will find the 2024 Housing Allowance form: This Form is for or your records and tax purposes. This form should be signed by you and the church secretary or a Board member if the church is sovereign.
- ❖ If the church is a District Church, please send the form completed and sign by the pastor to the Secretary Office for her to sign it, and returned to you for your records.

LATE RENEWAL

- Late Renewal Fee: January 1st through January 15th 2024, you should include a check for General Council and for SPD as mentioned above.
 - \$25.00 please make the check payable to "General Council"
- Reinstatement Fee for lapsed credentials beginning January 16th, 2024
 - \$175 if form is received after the January 15, your credentials are considered Lapsed.

REINSTATEMENT

- ❖ All applications received after *January 16, 2024 WILL NOT BE PROCESSED*. You must then call our office to request a reinstatement application.
- ❖ If you do not renew your credentials before the deadline, your credentials will lapse; therefore, you are forfeiting your status as minister of the Assemblies of God. If you are pastoring, please refer to Article VI Section 4 of the Constitution.
- Please, avoid letting your credentials lapse, as reinstating your credentials may require to do a new background check.

Please verify the following before submitting your renewal form.

- 1. Fill in all the blanks on the renewal form, there are some new questions, and do not forget to sign it.
- 2. Please send the district's renewal form to our office by October 31.
- 3. If you are a pastor, your church dues must be current. Don't forget to include church dues if applicable.
